


Five Year Comparison - Calls for Service




Five Year Comparison – Calls for Service






2023 Crimes Against Person






2023 Crimes Against Property






2022 Crimes Against Society






Five Largest Categories – Percent of Total Crime






Group A Crime Rate (per 1000 residents)






Violent Crime Rate (per 1000 residents)




Animal Control – Calls for Service





Article 1

The undersigned Bidder proposes and agrees, if this Bid is accepted, to enter into an agreement with Owner in the form included in the Contract Documents to perform and furnish all Work as specified or indicated in the Contract Documents for the Contract Price and within the Contract Time indicated in this Bid and in accordance with the other terms and conditions of the Contract Documents.

Potential bidders can download all bid documents and addendums at Washougal's e-procurement website (https://procurement.opengov.com/portal/cityofwashougal). For any potential Bidder not signed up through the e-procurement portal, further instructions are located on the City's bid opportunities website (https://www.cityofwashougal.us/748/Bid-Opportunities).

Article 2

Bidder accepts all of the terms and conditions of the Invitation to Bid and Instructions to Bidders, including without limitation those dealing with the disposition of Bid Security. This Bid will remain subject to acceptance for thirty (30) days after the day of Bid opening. Bidder will sign and submit the Agreement with the Bonds and other documents required by the Bidding Requirements within ten (10) days after the date of the Owner's Notice of Award.

Article 3

In submitting this Bid, Bidder represents, as more fully set forth in the Agreement, that:

(a) Bidder has examined copies of all the Bidding Documents.

(b) Bidder has examined copies of the following Addenda (receipt of which is hereby acknowledged):

- (c) Bidder has familiarized itself with the nature and extent of the Contract Documents, Work, site locality, and all local conditions and laws and regulations that in any manner may affect cost, progress, performance, or furnishing of the Work.
- (d) Bidder has studied carefully all reports and drawings of subsurface conditions and drawings of physical conditions which are identified in Section 00200, Information Available to Bidders.

Bidder has read and accepts the provisions in General Conditions paragraphs 3.3 through 3.5 which limit the extent to which the Contractor may rely on information provided by the Owner or the Design Engineer with regard to: a) subsurface soil conditions, b) existing concealed or underground utilities and underground facilities, and c) existing structures and facilities.

- (e) Bidder has read and accepts the provisions in General Conditions paragraphs 3.6 and 3.8 identifying the Contractor's responsibility: a) for using care in making excavations and in doing demolition, b) for damage to existing utilities and underground facilities and for loss of use thereof, and c) for the protection of workers and others from known and unknown or concealed hazards.
- (f) Bidder has read and accepts the provisions in General Conditions paragraph 3.7 which identifies the limited conditions under which the Contractor may be entitled to a change in Contract Time or Price due to differing or unknown conditions.
- (g) Bidder has visited the site and has reviewed the Bidding Documents and the Information Available to Bidders and it has made any other investigations, explorations, or tests and has obtained any other data it considers necessary for preparation of its Bid.
- (h) Bidder has correlated the results of all such observations, examinations, investigations, explorations, tests, reports, and studies with the Contract Documents and Bidder has read and understands provisions in the General Conditions relevant to differing and unknown conditions.
- (i) Bidder has given Engineer written notice of all conflicts, errors, or discrepancies that it has discovered in the Contract Documents and the written resolution thereof by Engineer is acceptable to Bidder.
- (j) Bidder has read, studied, and understands the entire set of Bidding Documents including the Construction Drawings, Specifications, and General Conditions and finds them fit and sufficient for the purpose of preparing its Bid and constructing the Work required.

- (k) Bidder represents that its Bid is based on providing all of the material, labor, equipment, and services necessary to complete the Work in full compliance with the Contract Documents without exception.
- (I) Attached is a Bid Bond duly completed by a guaranty company authorized to carry on business in the State of Washington, in the amount of no less than five percent (5%) of the total amount of our proposal, or alternatively, there is attached a certified or cashier's check payable to the City of Washougal in the amount of no less than five percent (5%) of the total amount of our proposal.
- (m) We further agree, if our Bid is accepted and a Contract for performance of Work is entered into with the City of Washougal, to so plan the Work and to prosecute it with such diligence that all the Work shall be completed within the time period stated in the Contract. We understand that the City of Washougal reserves the right to reject any or all bids and to determine which proposal is, in the judgment of the City of Washougal, the lowest responsible bid, and which proposal, if any, should be accepted in the best interests of the City of Washougal and that the City of Washougal also reserves the right to waive any informalities in any proposal or bid.
- (n) We further state that we have not, either directly or indirectly, entered into any agreement, participated in any collusion, or otherwise taken any action in restraint of free competitive bidding in connection with such contract.

Article 4

Requirements for State of Washington Public Works Contracts.

- (a) DECLARATION OF LICENSE STATUS. In accordance with Title 18.27 of the Revised Code of Washington, the Bidder declares that it possesses a valid State of Washington General Contractor's license at the time of submitting this Bid. Bidder shall state its license number and expiration date on its Bid Form.
- (b) **EXCAVATION, TRENCHING, AND SHORING**. The Bidder's attention is directed to Part N EXCAVATION, TRENCHING, AND SHORING, Chapter 296-155 of the Washington Administrative Code. These regulations relate to all excavation and contain specific requirements to provide for the protection of all employees during all excavation work in connection with all construction work relating thereto, such as trenches, underpinning, shoring and bracing, and in connection with the construction of footings, foundations, retaining walls, and other construction work below ground level.
 - The Bid schedule includes an item for Excavation Safety. The Bidder shall include its costs to provide the required worker protection as required by Washington State Law.
- (c) PREVAILING WAGE RATES. The undersigned agrees that, if awarded the Contract, the undersigned and all of its subcontractors shall pay all laborers, workers, and mechanics employed in the performance of such Contract, or any subcontract thereunder, not less than the general prevailing rate of per diem wages and rates for overtime and legal holidays in the locality in which the Work is to be performed, as ascertained and determined, by the statutes, regulations, and Section 00800 applicable thereto.

- (d) WASHINGTON STATE AND LOCAL SALES TAXES. The Owner will pay monthly to the Contractor, Washington State and local sales taxes at the current prevailing rates based on the progress payment amount. The Contractor shall then pay these State and local sales tax amounts to the Washington State Department of Revenue. The Contractor's obligations regarding RCW Title 82, Excise Taxes, are explained in a comprehensive manual entitled, Contractor's Tax Manual, available from the Research & Information Division of the Washington State Department of Revenue. In addition, the Washington Administrative Code Sections 458-20-102, 145, 170, 171, 172, 173, and 235 contain specific provisions relating to sales/use taxes.
- (e) The Bidder must provide a written declaration that they meet the Bidder responsibility criteria in accordance with RCW 39.04.350. Under RCW 39.04.350, the evaluation of bids for public work projects must include verification that the Bidder meets mandatory Bidder responsibility criteria and any supplemental Bidder responsibility criteria, and a written declaration from the Bidder verifying under penalty of perjury the Bidder is in compliance with the responsible Bidder criteria requirements for wage and labor standards in Chapters 49.46, 49.48, and 49.52 RCW



- 1.1 Bid Security, made payable to the City of Washougal, shall accompany each Bid. Bid Security shall be in the form of a cashier's check or certified check in the amount of not less than five percent (5%) of the Bidder's maximum price, or in the form of a Bid Bond in said amount (in the form attached). The Contractor and any subcontractors will not knowingly employ or contract with an unauthorized alien. The Contractor shall provide verification of their

compliance immediately upon any City request. Failure by the Contractor to comply with such requests may be considered a breach of contract.

3. <u>Subcontractor Responsibility</u>: The Contractor shall include the language of this section in each of its tier subcontracts, and shall require all of its subcontractors to include the same language of this section in each of their subcontracts, adjusting only as necessary the terms used for the contracting parties. The requirements of this section apply to all subcontractors regardless of tier.

At the time of subcontract execution, the Contractor shall verify that each tier subcontractor meets the following bidder responsibility criteria:

- 1. Have a current certificate of registration in compliance with chapter 18.27 RCW, which must have been in effect at the time of subcontract bid submittal;
- 2. Have a current Washington Unified Business Identifier (UBI) number;
- 3. Have a current City of Washougal General Business License;
- 4. If applicable, have
 - a. Have Industrial Insurance (workers' compensation) coverage for the subcontractor's employees working in Washington, as required in Title 51 RCW;
 - b. A Washington Employment Security Department reference number, as required in Title 50 RCW;
 - c. A Washington Department of Revenue state excise tax registration number, as required in Title 82 RCW;
 - d. An electrical contractor license, if required by Chapter 19.28 RCW;
 - e. An elevator contractor license, if required by Chapter 70.87 RCW.
- 5. Not be disqualified from bidding on any public works contract under RCW 39.06.010 or 39.12.065 (3).
- 6. Have received training on the requirements related to public works and prevailing wage under RCW 39.04.350 and RCW 39.12. The bidder must designate a person or persons to be trained on these requirements. The training must be provided by the department of labor and industries or by a training provider whose curriculum is approved by the department. The department, in consultation with the prevailing wage advisory

committee, must determine the length of the training. Bidders that have completed three or more public works projects and have had a valid business license in Washington for three or more years are exempt from this subsection. The department of labor and industries must keep records of entities that have satisfied the training requirement or are exempt and make the records available on its web site. Responsible parties may rely on the records made available by the department regarding satisfaction of the training requirement or exemption.

4. Owner's Obligation: In consideration of the promises and agreements of the Contractor as set forth herein, and in consideration of the faithful performance and furnishing of the work and materials required by this Contract to the satisfaction of the Washougal City Council, the Owner agrees to pay to the Contractor in the manner and at the times provided hereinafter and in the Contract Documents, and in accordance with the ordinances of the City of Washougal and the laws of the State of Washington, the following sum as indicated:

Including 8.5% Washington State Sales Tax (if applicable)

The total amount paid to the Contractor by the City may not exceed \$26,038,481 and 00/100 Dollars (\$Twenty-Six Million Thirty-Eight Thousand Four Hundred Eight-One Dollars and No Cents).

The amount finally to be paid is, however, variable upon the work actually done and final payment will be made upon the basis of the amount of work done and the materials furnished and at the lump sum or unit prices fixed in the Contractor's Proposal or as modified by any or all approved Change Orders.

5. <u>Contractor's Insurance</u>: Contractor's liability insurance shall include completed operations and product liability coverage including:

Subcontractors shall also be required to maintain insurance at the above stated limits.

The City of Washougal shall be named as an additional insured under all insurance required herein.

- 6. <u>Contractor's Bond</u>: The Contractor agrees that before it undertakes performance of this Contract, it will file with the City of Washougal a Contract Performance Bond and Payment Bond, in the forms prescribed by the City of Washougal, in the full amount of the Contract price executed by itself as principal and by a surety company authorized to do business in the State of Washington as surety. The bonds shall comply with the laws of the State of Washington, and especially with the provisions of Revised Code of Washington, Chapter 39.08.
- 7. <u>Employment of Labor</u>: The Contractor agrees that all persons employed in it and by any of its subcontractors in work done pursuant to this Contract shall be in accordance with all federal, state, and local laws.
- 8. Payment of Labor: The Contractor agrees that all laborers, workers, or mechanics employed by it or by any subcontractor in the work of this Contract will be paid not less than the prevailing rate of wage for an hours work in accordance with the provisions of the Revised Code of Washington, Chapter 39.12, and all rules and regulations promulgated pursuant thereto. The State of Washington prevailing wage rates applicable for this public works project, which is located in Clark County, may be found at the following website address of the Department of Labor and Industries: https://fortress.wa.gov/lni/wagelookup/prvWagelookup.aspx. Based on the bid submittal deadline for this project, the applicable effective date for prevailing wages for this project is 3/1/2024.

In case any dispute arises as to what the prevailing rates of wages for work of a similar nature are and such dispute cannot be adjusted by the parties involved, the matter shall be referred to the

director of the Department of Labor and Industries of the State of Washington for arbitration, and the director's decision therein shall be final and conclusive and binding on all parties involved in the dispute.

9. <u>Payment to the Contractor</u>: Payment to the Contractor of the Contract price by the Owner shall be made in checks drawn on the fund provided, therefore. Payment shall be in the manner provided below unless another manner has been specified in Special Provisions.

Progress payments to the Contractor shall be made within 30 days of receipt of the signed progress payment request, as approved by the Owner, for work completed during the previous month. There will be reserved and retained from monies earned by the Contractor on estimates during the progress of the improvements of work, a sum equal to 5 percent of all such estimates. Said retained amount shall be held in trust in accordance with the Specifications and Revised Code of Washington Ch. 60.28.

Payment of the retained percentage shall be withheld, by the owner, for a period of 45 days following the completion of all Contract work, as defined by WSDOT Section 1-01.3, and shall be paid the Contractor at the expiration of 60 days per RCW 39.12 and RCW 60.28, in the event no claims, as provided by law, have been filed against such funds; and provided further, that releases or certificates have been obtained from the State Department of Labor and Industries, from the State Department of Revenue, and the Employment Security Department and all other departments and agencies having jurisdiction over the activities of the Contractor. In the event such claims are filed, the Contractor shall be paid such retained percentages less an amount sufficient to pay any such claims, together with a sum sufficient to defray the cost of foreclosure action and to cover attorney fees as determined by the Owner.

Every person performing labor or furnishing supplies toward the completion of said improvement of work shall have a lien upon said monies so reserved; provided, that such notice of the lien of such claimant shall be given in the manner provided in Revised Code of Washington 39.08.030 and within the time provided in RCW 60.28 as now existing and in accordance with any amendments that may hereafter be made thereto.

No payment shall be made to the Contractor, however, until the Contractor and all subcontractors who have performed work shall have filed, with Procurement Services, the Labor and Industries executed Statement of Intent to Pay Prevailing Wage as required by Revised Code of Washington 39.12.040. Said Contractor and all subcontractors shall also keep accurate payroll

records for three years from the date of acceptance as described in WAC 296-127-320 *Payroll*. A Contractor and all subcontractors shall, within ten days after it receives a written request, as defined by RCW 39.12.010(4) file a certified copy of the payroll records with the Owner. A contractor's noncompliance with this section shall constitute a violation of RCW 39.12.050.

10. <u>Indemnity</u>:

- A. CONTRACTOR'S RESPONSIBILITY. Contractor agrees to indemnify, defend, save, and hold harmless the City, its officials, employees, and agents from any and all liability, demands, claims, causes of action, suits, or judgments, including costs, attorney fees and expenses incurred in connection therewith, or whatsoever kind or nature, arising out of, or in connection with, or incident to, the negligent performance of services by Contractor pursuant to this Agreement. This indemnification shall not include personal injury claims by outside third parties, except insofar as the claim relates to a latent condition not disclosed to the City.
 - 1. In the event that any suit based on such a claim, demand, loss, damage, cost, or cause of action is brought against the Contractor, the City retains the right to participate in said suit.
 - 2. This indemnity and hold harmless shall include any claim made against the City by an employee of Contractor or subcontractor or agent of the Contractor, even if Contractor is thus otherwise immune from liability pursuant to the workers' compensation statute, Title 51 RCW. To the extent that such liability arises from the concurrent negligence of both the City and the Contractor, such cost, fees, and expenses shall be shared between the City and the Contractor in proportion to their relative degrees of negligence. This indemnity and hold harmless shall NOT apply in the case where liability arises from the sole negligence of the City. Contractor specifically acknowledges that the provisions contained herein have been mutually negotiated by the parties and it is the intent of the parties that Contractor provide the broadest scope of indemnity permitted by RCW 4.24.115.
- 11. Ownership of Records and Documents Public Disclosure: All materials, writings and products produced by the Contractor in the course of performing this Contract shall immediately become the property of the City. In consideration of the compensation provided for by this Contract, the Contractor hereby further assigns all copyright interests in such materials, writings, and products to the City. A copy may be retained by the Contractor. In the event the City receives a public

record request for such materials, writings of products the City may, in its discretion, notify the Contractor of such request and withholds disclosure of such information for not less than five (5) business days to permit the Contractor to seek judicial protection of such information, provided that the Contractor shall be responsible for attorney fees and costs in such action and shall save and hold harmless the City from any costs, attorney feels, or penalty assessment under Ch.42.56 RCW.

- 12. <u>Liquidated Damages:</u> The Owner and the contractor recognize that time is of the essence of this Agreement and that the Owner will suffer financial loss of the Work is not completed within the times specified in paragraph (a) below, plus any extensions thereof allowed in accordance with Article 11 of the General Conditions. They also recognize the delays, expense, and difficulties involved in proving in a legal or arbitration proceeding the actual loss suffered by the Owner if the Work is not completed on time. Accordingly, instead of requiring any such proof, the Owner and the Contractor agree that as liquidated damages for delay (but not as a penalty) the Contractor shall pay the Owner One thousand dollars (\$1000) for each day that expires after the time specified in Article 2 (a) for Completion until the Work is fully complete and Owner issues notice of Final Completion.
 - (a) Time of Performance: In accordance with the Specifications the Contractor further agrees to plan the Work and to prosecute it with diligence and shall commence the Work within ten (10) days after the date established in Notice to Proceed from the Owner and shall Finally Complete the Work within Six Hundred and Five Days (605) calendar days from date of commencement in the Notice to Proceed.
 - (b) The Contractor expressly waives its immunity under industrial insurance, Title 51 RCW or any other similar state or federal workers' compensation or industrial insurance law. The parties stipulate and represent that this waiver has been mutually negotiated, is a material provision in this Agreement and that each indemnitee has relied upon such waiver.
- **Assignment:** This Contract is binding on each party, its successors, assigns, and legal representatives and may not, under any circumstances, be assigned or transferred by either party without express written authorization.
- **14.** <u>Termination for Convenience:</u> The City, at its sole discretion, may terminate this Contract for convenience at any time for any reason deemed appropriate. Termination is effective immediately upon notice of termination given by the City.
- **14**. **<u>Bid Documents & Contract</u>**: The complete Contract includes these parts: the Contract Form, Bidder's complete Proposal Form, Contract Plans, Contract Provisions, Standard Specifications,

Standard Plans, Addenda, various certifications and affidavits, supplemental agreements, change orders, and subsurface boring logs (if any). These parts complement each other in describing a complete Work. Any requirement in one-part binds as if stated in all parts.

- 15. Coordination of Contract Documents, Plans, Special Provisions, Specifications and Addenda: As defined in section 1-04.2 in the Standard Specifications for Road, Bridge and Municipal Construction as published by the Washington State Department of Transportation as modified by the Special Provisions, provided that this contract form shall supersede in the event of conflict.
- 16. Force Majeure: If either party fails to fulfill its obligations hereunder (other than an obligation for the payment of money), when such failure is due to an act of God, or other circumstances beyond its reasonable control, including but not limited to fire, flood, civil commotion, riot, war (declared and undeclared), revolution, or embargoes, then said failure shall excuse both party's performance for the duration of such event and for such a time thereafter as is reasonable to enable the parties to resume performance under this Agreement, provided however, that in no event shall such time extend for a period of more than one hundred eighty (180) days
- 17. <u>Notices</u>: Whenever in this written Contract written notices are to be given or made, they may be sent to the following people at the addresses as shown herein unless a different address is designated in writing or delivered to the respective party hereto:







Background

- *"Solid Waste Collection and Transfer Station Development and Operation Agreement" dated March 23, 2009
 - √15-year term (expires March 23, 2024) with renewal option by mutual agreement for up to four successive 5-year terms
 - ✓ Provides exclusive right to collect, remove and dispose of all solid waste, recycling and yard waste (set initial fees with authorized CPI based annual increase)
 - ✓ Provided for the development of the Washougal Transfer Station (completed)
 - ✓ Provides for a monthly payment to City: started At \$10,416.67/month, with an automatic annual escalator consistent with the CPI for the tipping fee (currently \$14,345.49/mo = \$172,146/yr)
 - ✓ Provides for an additional payment to the City for annual tonnage over 20,000 (percentage of tonnage over 20,000 multiplied by base fee: 2022 payment = \$152,234 based on 39,836 tons; estimated 2023 payment = \$162K-\$174K)

FIRST AMENDMENT TO SOLID WASTE COLLECTION AND TRANSFER STATION DEVELOPMENT AND OPERATION AGREEMENT

This First Amendment ("First Amendment") to Solid Waste Collection and Transfer Station Development and Operation Agreement is entered into this _____ day of ______ 2024, by and between the City of Washougal (the "City") and Waste Connections of Washington, Inc. (the "Contractor"). City and Contractor may be referred to herein collectively as the "Parties".

WHEREAS, the Parties entered into that certain Solid Waste Collection and Transfer Station Development and Operation Agreement on or about March 23, 2009 (the "Agreement"); and

WHEREAS, the Parties desire to amend the Agreement to address provisions relating to the term of the Agreement, the rates stated therein and such other amendments as set forth more particularly herein;

NOW, THEREFORE, in consideration of the mutual promises herein, the Parties, intending to be legally bound, hereby agree as follows:

- 1. <u>Term.</u> Section 4 of the Agreement is hereby deleted in its entirety and replaced with the following:
 - 4. <u>Agreement Term.</u> The term of this Agreement shall be extended and continue until midnight (12:00 a.m.) July 31, 2033, with the option of renewing said term upon the mutual Agreement of the parties for successive periods of five (5) years, not to exceed two (2), five (5) year renewals.
- 2. <u>Indemnification, Hold Harmless Clause</u>. Section 5 of the Agreement shall be deleted in its entirety and replaced with the following:
 - 5. <u>Indemnification, Hold Harmless Clause</u>. The Contractor agrees and guarantees to hold harmless, defend and indemnify the City, its officers, agents and employees or any of them, from any and all suits and all claims, actions, liability, losses, costs, expenses, and damages of any nature whatsoever, which may arise or may be brought against the City arising out of the performance of this Agreement by the Contractor to the extent arising from the Contractor's acts of negligence or willful misconduct. The Contractor shall defend the same at its sole cost and expense; provided that the City retains the right to participate in such suit if any principal or governmental or public laws is involved. If a final judgment is rendered against the City, and its officers, agents, and employees, or any of them, the Contractor shall satisfy the same.

3. <u>Breach of Contract</u>. The following shall be added to the end of the existing Section 8 of the Agreement:

If the City shall be in breach of any provision of this Agreement, Contractor may suspend its performance hereunder until such breach has been cured or terminate this Agreement; provided, however, that no termination of this Agreement by Contractor shall be effective until Contractor has given written notice of such breach to the City and the City has failed to cure such breach within thirty (30) days after its receipt of such notice. Upon any such failure to cure, Contractor may terminate this Agreement by giving the City written notice of such termination, which shall become effective upon receipt of such notice.

- 4. <u>Transfer Station Development Complete</u>. The Parties acknowledge that as of the date of this First Amendment, development of the Transfer Station has been completed and the obligations of the Parties concerning development of the Transfer Station have been satisfied.
- 5. Condition and Care of Transfer Facility. A new section 16.5 shall be adopted into the Agreement as follows:
 - 16.5 <u>Improvements, Repairs and Maintenance Identified by Study</u>: In addition to routine maintenance and ordinary wear and tear, Contractor is solely responsible for the obligation and cost to complete any and all capital improvements, repairs, and maintenance identified in the Clark County Regional Solid Waste System Study Phase 2 Report: Regional Systems Facility Plan, and as a result of inspections performed by Parametrix on behalf of Clark County.
- 6. <u>Transfer Station Payment to the City.</u> Section 20 of the Agreement is hereby deleted in its entirety and replaced with the following:
 - 20. <u>Transfer Station Payment to City</u>. Contractor will pay the City thirty thousand and 00/100 dollars (\$30,000.00) per month during the term in which Contractor has exclusive right to operate, beginning the first day of the next month following the effective date of this First Amendment.
- 7. <u>Additional Payment to City</u>. Section 21 of the Agreement is hereby deleted in its entirety and replaced with the following:
 - 21. <u>Additional Payment to City</u>: Beginning on the effective date of this Amendment and through February 2027, the additional payment to the City pursuant to Section 21 of the Agreement is suspended. No later than January 4, 2027, the Parties shall commence negotiations to amend the provisions of Section

21 of the Agreement regarding additional payments to the City based on whether the total annual delivered tonnage exceeds 50,000 tons, or other such tonnage or provisions as agreed by the Parties.

8. <u>Monitoring and Reporting Tonnage</u>. Section 45 of the Agreement is hereby deleted in its entirety and replaced with the following:

45. Reporting:

(a) Cooperation and Reports: Contractor may be required by the City to bring in or submit to audit and inspection at any reasonable time (by duly authorized City employees) such other field or accounting reports and financial records as may reasonably be necessary for proper municipal supervision of this Agreement, even though they may not be specifically mentioned herein. All information so obtained shall be confidential and shall not be released by the City, unless subject to disclosure under applicable public disclosure laws, or unless expressly authorized in writing by the Contractor or unless in statistical form which identifies no persons.

By the 10th day of each month, the Contractor shall submit to the Director of Finance a report as to all services performed in the previous month under this Agreement, including all special services, and whenever any new services or any change in type or extent of service has occurred during such previous month, same shall be specified in such report. Accounting records of the Contractor related to this Agreement shall utilize the Generally Accepted Accounting Principals (GAAP) or a similar type approved by the City Finance Director.

(b) Monitoring and Reporting Tonnage: By February 1 of each year, Contractor will provide detailed reports of the tonnage delivered to the Transfer Station for the previous calendar year.

All incoming loads of Solid Waste to the Transfer Station must be weighed. Scale logs and monthly summaries and any other documentation as may be reasonably required by the City shall be attached as support for calculation of the total payment to City. The City reserves the right to require 24-hour video surveillance of the scales.

- 9. <u>Settlement Payment to City.</u> A new section 21.5 shall be adopted into the Agreement as follows:
 - 21.5 <u>Settlement Payment to City</u>: The Parties entered into an agreement entitled Settlement of Claims and Mutual Release Agreement, dated October 6, 2023, wherein Contractor agreed to pay the City Six Hundred Eighty Four Thousand Two

Hundred and Twenty Dollars (\$684,224). The Parties acknowledge this has been paid in full.

- 10. <u>Successors and Assigns Bound</u>. In the event that ownership of the Transfer Station is transferred during the term of this Agreement, the City's successors and assigns shall be bound by the Agreement for the remainder of the term of the Agreement.
- 11. <u>City Manager to Supervise Contract.</u> The first paragraph of Section 37 of the Agreement shall be deleted in its entirety and replaced with the following:

The performance by the Contractor under this Agreement shall be under the general direction of the Mayor of the City or their designate.

- 12. <u>Ratification; Full Force and Effect</u>. All terms and provisions of the Agreement not amended hereby, either expressly or by necessary implication, shall remain in full force and effect.
- 13. <u>Conflicting Provisions</u>. In the event of any conflict between the original terms of the Agreement and this First Amendment, the terms of this First Amendment shall prevail.
- 14. <u>Authorization</u>. Each party executing this First Amendment represents and warrants that it is duly authorized to cause this First Amendment to be executed and delivered.
